

## TERMS AND CONDITIONS (effective as of April, 15 2014)

BY PARTICIPATING YOU AND YOUR PARENTS CONFIRM THAT YOU HAVE READ AND AGREE TO THE REQUIREMENTS SET OUT IN ALL THE PROMOTIONAL MATERIALS AND THE FOLLOWING GENERAL TERMS AND CONDITIONS.

1. The promoter of “Bloxy Weekly Contest” [“the competition”] is: Bloxy Sp. Z o.o. whose registered office is located at Al. Jerozolimskie 56c, 00-803 Warsaw, Poland.
2. Employees of Bloxy Sp. Z o. o. or their family members or anyone else connected in any way with the competition or helping to set up the competition shall not be permitted to enter the competition.

7. Closing date for all the entries will be [May, 13 2014, 3:59 pm, GMT]. After this date, no further entries to the competition will be permitted.
